NET update - Queens Road West / Meadow Lane junction, Chilwell

As you may be aware, the Queens Road West / Meadow Lane junction is being improved as part of the works to extend Nottingham's tram system to Beeston and Chilwell. The changes are needed to improve traffic flow through the junction so that traffic heading towards Nottingham uses Queens Road instead of Chilwell Road / High Road, especially once the tram comes into operation.

The next stage of these works involves resurfacing the carriageway at this junction on the weekend of 1st and 2nd December, and the following weekend, 8th and 9th December, from 8am – 10pm each Saturday and from 8am – 5pm each Sunday.

So that these works can be carried out safely, Meadow Lane will be closed at its junction with Queens Road West while these works are taking place, and two-way temporary traffic lights will be in use on Queens Road West, which will remain open in both directions. A signed diversion route for traffic will be in place.

The works on Queens Road at the Meadow Lane junction will be completed and the temporary restrictions will be removed in the run-up to Christmas, to assist shoppers and traders at this busy time of year. Where practical, tram works taking place on the main routes into Beeston Town Centre and Nottingham City Centre, including University Boulevard, will also be removed until the New Year.

Please allow extra time for journeys through the junction while the works take place. The works will be in accordance with the Code of Construction Practice (CoCP), which was agreed at the NET Phase Two public inquiry held in 2007.

The CoCP regulates the way that works for NET Phase Two can be undertaken, and sets out standards for our contractor on issues such as controlling noise, vibration and dust. This will ensure that works are undertaken in a responsible and sympathetic manner.

We apologise in advance for any inconvenience that these works may cause you, and would like to assure you that we will do all that we can to keep disruption to a minimum.
